Memorandum of Understanding (MoU)

Duration of MoU:

This MoU unless extended by mutual written consent of both institutes, shall expire in FIVE YEARS after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended for ANOTHER FIVE YEARS by mutual consent.



Objectives of MoU:

1. To promote and enhance academic interest.
2. To provide advice for implementation of quality education.
3. To encourage bright students of both colleges for excellence in their subjects and for post graduation.
4. To conduct research projects under joint venture.
5. To imbibe scientific attitude among the students.

Proposed model of Collaboration:

1. Exchange of faculty and students for sharing knowledge.
2. Guidance to the students for research projects.
3. Organization of Seminars, Conferences, Workshops and Guest lecturers under joint venture.
4. Availability of departmental library to the faculty and students of both colleges.
5. Organization of other academic and extension activities.

Terms and Conditions:

1. This MoU may be amended, renewed and/or terminated by mutual written agreement of both the institutions at any time.
2. Either institution shall have the right to terminate the MoU upon 60 days of prior written notice to the other institute.

Coordinators:

Heads of both institutions will designate persons who have responsibility of coordination and implementation of this MoU.
