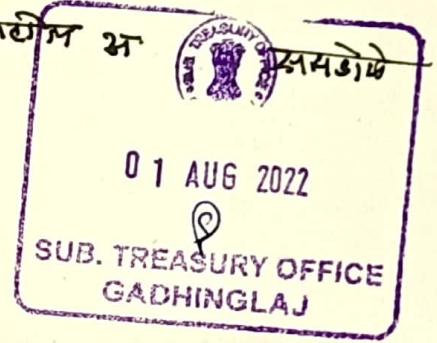

### **Purpose & Scope:**

This MoU is executed to strengthen analytical skills, to exchange faculty, knowledge exchange and to enhance inter-institutional interaction for mutual benefits.

### **Objectives of the MoU:**

The objectives of the MoU are:

1. To enhance analytical skills.
2. To provide advice for implementation of quality education.
3. To enhance soft skills.
4. To organize jointly placement activities/ guest lectures.

### **Responsibilities under this MOU:**

1. To exchange faculty.
2. To exchange students for sharing knowledge.
3. To guide students for research project.
4. To organize guest lectures and hands on training workshop to improve analytical skills.
5. To organize and collaborate for campus placement activities.
6. To share laboratory facilities for faculty/ students collaborative research.

### **Funding:**

The cost of cooperative activities may be funded as mutually determined.

### **Terms and Conditions:**

1. This MoU may be amended, renewed and terminated by mutual agreements of the institution at any time.
2. Either institution shall have the right to terminate this MoU upon 60 days prior written notice to the other institute.

### **Duration of MoU:**

This MoU, shall be effective upon the signature of authorized officials. It shall be in force from **3<sup>rd</sup> September, 2022 to 2<sup>nd</sup> September, 2027.**

However, on review, the MoU shall be extended for another three years by mutual consent.



**Coordinators:**

Both institutions will designate persons who have responsibility for co-ordination and implementation of this agreement.


