





To study the protective changes in the social institution of marriage due to intermarriage.


Hypothesis

Religious rituals for marriage are not as important today as some have been before in the past. The elderly of the family used to select a spouse for their family member. For this, help was taken to select the right places for the people of the caste community and the people of the society. But today boys and girls are selecting each other. Boys and girls are love marrying and intermarrying regardless of caste religion, due to various reasons such as co-education, Job related contact, Physical attractiveness, temperament intense love, premarital sex and progressive thinking. In order to match weddings, advertisements are published through the news paper, websites. At the same time there are brides for every caste and bride who wants to marry.

The change in the traditional mind set of advanced education and the pursuit of employment is reflected in the increasing age of marriage. Due to the legally ban of child marriage, the prevalence of child marriage has dropped drastically today. Adult marriages appear



instead of child marriages. At the same time because of love marriage and intermarriage, the dowry system is being abolished. Young boy and girl are getting married without a dowry.

Windows were never remarried. Window remarriage has increased because of legal recognition of widow marriages. In the past, widows had to be humiliated while living in the community. But today, the remarriage of widows shows that the society has been recognized. Young boy and girl are getting married without a dowry.

In the past, women had a secondary place in the decision making process of marriage. This traditional mindset is changing today, women are also being involved in the decision making processes. Even from women the making process of choosing their own spouse is underway. Women are playing the role of family head in some families. Although the scale is small, Women appear to prove their existence in their family. The wedding ceremony, which was celebrated for four to five days in the past, appears to have changed. The number of marriages is increasing with the legal registration system.

Inter-marriage creates family relations between two different castes religion and ethnicities. Relatives of two different breeds come together over time. Therefore, changes in eating and drinking and customs practices are also seen. Because people from two different cultures come together, People from both cultures are seen as leaving them together. By changing the traditional traditions and the traditional mindset, one has to accept the existence of another person today. Live in relationship means that men and women live together without marriage. Today, this being viewed as a necessity of time. At the same time sexual attraction and sexual action between two persons of the same sex are called homosexuality. The prevalence of homosexuality is low in India but in other countries same –sex marriage is seen as legal. In India too, some organizations appear to be trying to again legal recognition for same sex and same sex marriage.
